## CAMPSPOT HOLIDAY "TWELVE DAYS OF CAMPMAS" GIVEAWAY OFFICIAL RULES

## NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. **SPONSOR**: This Campspot Holiday "Twelve Days of Campmas" Giveaway ("**Sweepstakes**") is sponsored by RezPlot Systems, LLC d/b/a Campspot, 38 Commerce Ave. SW, Suite 200, Grand Rapids, MI 49503 ("**Sponsor**").
- 2. **WHO** IS ELIGIBLE: The Sweepstakes is only open to those who sign uр at https://www.campspot.com/about/campmas who (a) are at least eighteen (18) years of age at the time of entry and the age of majority in their jurisdiction of residence at the time of entry. The Sweepstakes is open to legal residents of the forty-eight (48) contiguous United States and the District of Columbia, excluding residents of Puerto Rico, all U.S. territories and possessions, and all overseas military installations, and is void where prohibited by law. Employees, independent contractors, interns, officers, directors, and agents of the Sponsor, their respective affiliates, subsidiaries, advertising and promotion agencies and suppliers (collectively, the "Sweepstakes Entities") and their immediate family members and/or those living in the same household (whether legally related or not) are not eligible to participate in the Sweepstakes. For additional entries each day, participants can (i) download the Campspot app (ii) visit Campspot.com. The entry must fulfill all requirements of the Sweepstakes, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications of the Sweepstakes may be disqualified at the sole discretion of the Sponsor.
